Dear Fellow Fulton County Resident:

You have been summoned for service as a prospective member of the Fulton County Grand Jury. I write to provide you with information and assurance regarding the extensive safeguards your Superior Court has taken to safeguard your health and well-being during your upcoming visit to the Fulton County Courthouse.

Despite the difficult times we have all experienced as a result of the COVID-19 pandemic, the Superior Court of Fulton County has remained open, albeit with modifications to its operations. As you know, access to our justice system is guaranteed by the Constitution, and your court system remains open to serve the public and safeguard our rights as citizens. Operations in the Courthouse have been transformed to protect the safety of all who enter.

So that you may answer the call as a summoned juror without any unnecessary risk, the Court has implemented the following health and safety precautions:

- Each person seeking to enter the Courthouse must review a list of screening questions designed to prevent entry into the Courthouse by anyone at increased risk of spreading the COVID-19 virus.
- Thermal scanners are used to check the body temperature of every person entering the Courthouse, and those with a fever will not be admitted.
- Following CDC guidelines, the Court will enforce the recommended 6-feet of social distancing throughout the Courthouse, including in entrance areas, in elevators, on escalators, and in courtrooms. Also, everyone who enters the Courthouse must wear a mask or facial covering. We ask that you bring your own mask; but if you do not have one, a mask will be provided.
- Sanitary Plexiglas shielding has been installed in all courtrooms to protect visitors and staff.
- Extensive cleaning in all areas of the courthouse is ongoing throughout the day, and ample supplies of hand sanitizer and disinfectant wipes will be readily available to all jurors.
- All the Court's safety plans have been formulated in conjunction with the Board of Health, and meet all CDC guidelines for COVID-19 safety.
